Friedrich Steinhäusler

Prof. Friedrich Steinhäusler is currently Full Professor of Physics and Biophysics at the University of Salzburg (Austria) and Director of the *Government Radiological Measurements Laboratory Salzburg* (Austria). He is also Vice-President of the *International Security Competence Centre* (Vienna, Austria) and serves as Member of the *Austrian Government Forum for Nuclear Issues*.

In the recent past he served as *Chairman* of the US/German Transatlantic ERP Expert Group „Global Fight Against Terrorism“, and the NATO CLG Expert Group “Terrorism Threats against Nuclear Power Plants and Spent Fuel Transport”. Furthermore he was *Co-Director* of the NATO ARW “Catastrophic Terrorism and First responders: Threats and Countermeasures” and *Logistics Director* of the NATO ARW “Civil Protection and First Responders”. He also served as Programme Evaluator for the European Union Security Research Programme PASR 2004 and PASR 2005, FP 7 Security 2007, as well as for the Austrian Government Security Research Programme KIRAS in 2006.

Prof. Steinhäusler was Programme Coordinator for “Security” and Project Manager for “Protection of Nuclear Material against Theft and Sabotage” at Stanford University, California (USA), from 1999 to 2003. He organized the EU High-Level Scientific Conference on “Physical Protection of Nuclear Material (NUMAT)” in Salzburg (Austria) in 2003. In 2005 he conducted the international conference “Nuclear Energy and Security” in Salzburg. In 2007 he chaired the international conference on “Oil- and gas industry and security” (PETROSEC), organized jointly with the European Commission, Austrian Technologies and Security Research, and the US Postgraduate Naval School, in Salzburg (details at <http://www.enersec.at>).

Over the past 25 years Prof. Steinhäusler has worked for several international organisations as senior staff member and/or chairman of scientific committees, such as the International Atomic Energy Agency (IAEA), World Health Organisation (WHO), United Nations Industrial Development Organisation (UNIDO) and Organisation for Economic Development and Cooperation (OECD). In the area of *security* he collaborates actively with United Nations Interregional Crime and Justice Research Institute (Turino, Italy), INTERPOL (Lyon, France), EUROPOL (The Hague, The Netherlands), NATO (Bruxelles, Belgium), Dutch National Coordinator for Counterterrorism (The Hague, The Netherlands), German Special Security Forces (GSG-9; St. Augustin, Germany), and Austrian Armed Forces (NBC-Special Unit, Vienna, Austria), European Centre for Security Strategies (Munich, Germany). He has published internationally over 250 articles on risk assessment, safety and security.
